Designations Programs

IAIR serves as the credentialing organization for professionals who work on the resolution of troubled insurance companies



Accredited Insurance Resolutions Director (AIRD[™]) – This entry level designation signifies that the holder has demonstrated broad knowledge of insurance resolutions and the tools available to insurance regulators to resolve troubled company situations.



Certified Insurance Resolutions Director (CIRD[™]) – This advanced designation, available to AIRD holders after one year, signifies the holder has expertise in one or more specialty areas, such as accounting and financial reporting, actuarial, claims and guaranty associations, information technology, legal, reinsurance, and resolution management
